## TABLE 1

"Students available for graduation" equals the number of students who began the program minus the number of "Students unavailable for graduation," which means students who have died, been incarcerated, or called to active military duty, are international students that leave the United States or do not have a visa allowing employment in the United States, or are continuing their education in an accredited bureau-approved postsecondary institution.

"Graduates" is the number of students who have completed the program within 100% of the published program length.

"Completion Rate" is calculated by dividing the Number of Graduates by the Number of Students Available for Graduation.

"Completion Rate" means the number of students completing the program within 101-150% of the published program length.

"Graduates available for employment" means the number of graduates minus the number of graduates unavailable for employment. "Graduates unavailable for employment" means graduates who, after graduation, die, become incarcerated, are called to active military duty, are international students that leave the United States or do not have a visa allowing employment in the United States, or are continuing their education in an accredited or bureau-approved postsecondary institution.

"Graduates employed in the field" means graduates who are gainfully employed within six months of graduation in a position for which the skills obtained through the education and training provided by the institution are required or provided a significant advantage to the graduate in obtaining the position.

"Placement Rates" are calculated by dividing the number of graduates employed in the field by the number of graduates available for employment for a program that is: designed, or advertised, to lead to a particular career; or advertised or promoted with any claim regarding job placement.
